## ELIGIBILITY

1. Open to all artists, ages 18 and over
2. Entries must be original
3. **Entries must have been painted within the last two years.**
4. Work completed in a workshop or under supervision is ineligible. Work using photographs other than the artist's own is not considered original. Source material must be original and not derived from published images. Paintings submitted, but not exactly the same as entered images, will be disqualified.
5. Artwork will be reviewed by TWS screening committee to insure adherence to prospectus.

## CONDITIONS OF ENTRY

1. **Paintings must be water media on 100% rag or cotton paper.**
2. No collage will be accepted.
3. Minimum image size is 10"x14".
4. **Outside frame dimension cannot exceed 42" in any direction.**
5. Paintings must be matted and framed under plexi-glass & ready to hang. The frame must be simple, without ornamentation, sturdy enough to support art without buckling. No saw tooth hangers. Mats must be white or light colored neutral tones (a colored liner is acceptable).
6. **Paintings must be for sale.** The Artist will receive 60%, Patterson-Appleton, 30%, and TWS 10% of sales.
7. All paintings will be handled with care; neither TWS, nor the Patterson-Appleton Center will be held responsible for loss or damage of work submitted. Insurance coverage is the responsibility of the individual artist.

1. Limited to three images per artist
2. Nonrefundable Fee of \$45.00 for one to three images.

3. Use JPEG files only. Minimum size: 1200x1800 pixels (4x6). 300 dpi required for catalog publication purposes.
4. Images will be used in the catalog. Color rendition must be accurate.
5. Crop images to exclude frames or mats.
6. Images must represent the painting exactly.
7. Each image must have an entry number, artist's last name, and title to coincide with the entry form. Name images with first four letters of last name, # of painting, and name of painting.  
 i.e: Smit1Lilies.jpg/Smit2WoodGate.jpg etc.  
 Note: jpg will be automatically placed on the file when it is saved.

## CD ENTRIES:

1. Send Entry Form, Fee Check, and CD to Computer Systems, Inc., P.O.Box 171241, San Antonio, Texas 78217.
2. Place entry number, artist's last name, and titles on the top side of the CD with a permanent marker. Insure that each image is individually identified. Follow instructions for images listed in #'s 1 through 7 above. Use one CD. CD's will not be returned.

## ACCEPTED PAINTINGS

1. Accepted artists and instructions for shipping paintings will be posted on the TWS website on the date listed in the calendar and they will receive email notification as well. [www.texaswatercolorssociety.org](http://www.texaswatercolorssociety.org)
2. Only one painting per artist will be accepted for the exhibition.
3. Works may be hand delivered (\$30 handling fee) or shipped (\$50 handling fee). Shipping fees and insurance are the responsibility of the artist.  
**Note: Acceptance is a commitment to show. "No-shows" will be disqualified from entering for a period of two years.**

## AWARDS

Up to \$10,000 in cash, merchandise, and purchase prizes will be awarded. Best of Show: \$2000. One award of \$1000 is for a Texas resident. There will be several \$500 awards. A color catalog of all paintings will be produced and sent to each artist entering.
